Consultation Services

A review of the case discovery provided looking for any errors, or omissions, any evidence discrepancies, and ensure compliance with the appropriate regulations. An **à la carte** style options have been provided to assist in paying for only the services needed. A bullet point report of review notes is included, a summary with expert opinions is also available.

Paper Only: a review which provides guick feedback on the pros and cons of the case.

Vehicle Contact: a review of the initial traffic stop, crash or other reason for the contact with the driver.

Driver Contact: a review of the initial personal observations and interviewing of the driver.

Sobriety Tests: a review of the roadside sobriety testing conducted during the impaired driving investigation.

Chemical Test: a review of the blood or breath sample collection and toxicology results provided.

Crash Investigation: a review of the investigation, any follow up, and the proximate cause determination.

Toxicology Analysis: a review of the toxicology results, hospital, clinic, coroner or other medical records.

DRE Evaluation: a review of the drug influence evaluation and the opinion on any influencing drug categories.

Investigation Services

Scene Surveys where practical, of the incident location, witness locations and sobriety testing location. Looking for additional evidence and factors relevant to the case.

Evidence Inspections of involved vehicles and evidence collected by the initial investigators, to confirm information contained in reports and the relevance of the evidence to the case, along with looking for additional evidence.

Subject Interviews with involved parties to confirm statements and observations and searching for additional witnesses. Witness research and service of court documents can also be conducted in connection to the case.

Baseline Performance a DRE/SFST evaluation under controlled conditions to compare with the performance reported in the original investigation. Also a review of how medical conditions may have an adverse effect on sobriety tests.

Testimony Services

Expert testimony based on either my analysis of the case or blind testimony on areas of expertise.

Advisory witness support to the attorney in the court, observing testimony and providing feedback.

Court Transcripts reviewing court transcripts comparing testimony to written reports or training.

Educational Services
